
The National Consumers League: Women's Activism and Labor Standards in the New Gilded Age





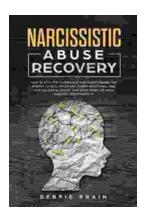
